After studying the results, a list of 19,000 books was compiled. Each on this basis

1045 texts consisting of 500 word forms were selected. The corpus as a conclusion selection of material (text) during the design process, sorting, its technical aspects it should be noted that adaptation to the body is the most basic stage.
