A basic essay is a reflection on a given topic, expressing one's feelings and thoughts in the text. At school, basic essays are written from elementary grades - at first they are descriptions of pictures or a view from a window. In high school, teenagers are invited to analyze literary works and reflect on eternal themes: friendship and love, life and death, career choice. Schoolchildren write basic essays not only on literature, but also on history, social sciences and foreign languages. The basic essay is written not only in schools but also in universities.

There are also legal rules for writing a basic essay in English. First of all, a topic for writing a basic essay is chosen, and based on that topic, sentences are made and written. The basic essay in English has at least 3 parts. These include Introduction, Body and Conclusion.

To write a basic essay in English, the first topic sentence is written. Topic sentence is included in the Introduction part of the essay. In the introduction part, the general meaning of the essay is given. *"The main idea of each paragraph is stated in a topic sentence that shows how the idea relates to the thesis"* (Lisa Bell, Kelsey Hixson-Bowles, 2011; p1) It expresses the main point of paragraph . A great topic sentence is particular sufficient to donate a clear sense of what to anticipate from the passage, but common sufficient that it doesn't deliver everything absent.

The introduction part of the essay should contain at least 4 sentences. Topic sentence is also part of those sentences. *"The introduction guides your reader into the paper by grabbing attention and introducing the topic. The ideas within the introduction should begin as very general and gradually get more specific until it ends with the thesis statement. "* (Lisa Bell, Kelsey Hixson-Bowles, 2011; p1). *"Regardless, the thesis sentence must be present and clearly stated. Without it, the rest of the paper will lack clear focus and structure."* ( Jessica Vanderhoff, 2012; p1).

Body contains facts, statements, examples, and details that lead you to fully understand the main idea. They clarify, clarify, explain, explain, extend, explain and support the main idea. There are six main types of supporting detail. There are six main types of supporting details: description, vocabulary, evidence, voice, description and significance. Furthermore, the author's own analysis and discussions of the topic is important. Supporting details might be figured out a variety of sources including books, interviews, experiences. The body of the essay holds up the main point of the thesis.

The main body consists of at least one paragraph. But most often the main body consists of two or three paragraphs, sometimes even more.

A conclusion is your chance to have the final say on the subject. A conclusion has the final say on the issues you dealt with in your work, summarizes your thoughts, indicates the importance of your ideas, and is on the topic that the last section of your work consists of. From the concluding paragraph or sentence and summarizing the main points in the work, it allows the reader to be introduced to new perspectives. The essay should end on a positive note. Every essay should end with a conclusion statement. It brings together the ideas cultivated in the paragraph and emphasizes the main idea one last time.

Writing an essay will definitely need some transitions and conjunctions. *"Transitions help paragraphs connect to each other and to the thesis. It can be one or two words ( First, Next, In addition, etc.)"* (Lisa Bell, Kelsey Hixson-Bowles, 2011; p2)

A conjunction is a service part of speech, with the help of which simple sentences are connected together as part of a complex or homogeneous members of a sentence. It does not decline or conjugate, and is not part of a sentence. Expresses semantic relationships between syntactic units. For example: However, and, but , when, while, until, till, therefore, nevertheless, moreover and others. If they are used in writing an

essay, the essay will be better and structurally more complex.

In conclusion, there are 3 main parts of the essay. Those parts should combine to provide general information about the article. In fact, there are many types of essays in terms of meaning. But all are written based on the same structure. The difference is that their title and content are meaningfully different.
