In 2013, about 87% of school-age children attended state-funded public schools, about 10 % attended tuition and foundation—funded private schools, and roughly 3 % were home schooled. Education is compulsory over an age starting between five and eight and ending somewhere between ages sixteen and eighteen, depending on state. Compulsory education is divided into three levels: elementary school, middle school and high school.

Numerous publicly and privately administered colleges and universities offer a wide variety in post-secondary education. *Post secondary education* is divided into college as the first tertiary degree and graduate school. Higher education includes public research universities, private liberal arts colleges, historically black colleges and universities, community colleges, for-profit colleges, and many other kinds and







combinations of institutions. Colege enrollment rates in the United States have increased over the long term. At the same time *student loan debt* has also risen.

According to a 2016 report published by the U.S *News & World Report* Of the top ten colleges and universities in the world, eight are American.

The United States spends more per student on education than any other country.

In 2014 the Economist Intelligence Unit rated U.S education as 14th best in the world. In 2000, 76. 6 million students had enrolled in schools from kindergarten through graduate schools. Of these, 72% aged 12 to 17 were considered academically "on track" for their age i.e. enrolled in at or above grade level. Of those enrolled in elementary and secondary schools, 5.7 million were attending private schools.

Over 85% of the adult population have completed high school and 27% have received a bachelor's degree or higher. The average salary for college or university graduates is greater than \$51,000, exceeding the national average of those without a high school diploma by more than \$23,000, according to a 2005 study by the U.S Census Bureau. The 2010 unemployment rate for high school graduates was 10.8 %; the rate for college graduates was 4.9%.

The country has a reading literacy rate of 99% of the population over age 15, while ranking below average in science and mathematics understanding compared to other developed countries. In 2014 a record high of 82% of high school seniors graduated, although one of the reasons for that success might be a decline in academic standards.

The poor performance has pushed public and private efforts such as the *No CHild Left Behind Act*. In addition, the ratio of college-educated adults entering the workforce to the general population (33%) is slightly below the mean of other developed countries (35%) and rate of participation of the labor force in continuing education is high.
